To receive a rebate, the existing insulation level must be less than R19 as determined by an insulation contractor or customer verification. Today's Florida Energy Efficiency Codes require a minimum of R19 Ceiling Insulation; however, R30 is recommended. The insulation shall be installed in a residence or facility receiving electrical service from CEC.
