The window film shall be installed on existing windows in a residence or facility receiving electrical service from CEC. To receive a rebate, the window film must have a Solar Heat Gain Coefficient (SHGC) of $\leq .45$ and installed on windows that have a western, eastern or southern orientation and are not shaded by permanent structures.
