Annual Meeting on March 25 is an opportunity to celebrate the co-op

Our gathering with you each March is the perfect time to reflect on the successes of our cooperative and update you on important projects and matters. We hope to see you March 25.

2022 was another historic year filled with change and progress. Despite considerable growth and more difficulties caused by supply chain issues and the volatility of the natural gas market, Clay Electric remained steadfast in our purpose to deliver low-cost, reliable electricity while supporting the communities it serves.

In addition to challenges around us, your cooperative saw wide-scale development last year — adding approximately 6,000 additional accounts billed from December 2021 to December 2022. But through it all, we accomplished an amazing list of goals as we adapted to change and learned to serve you — our members — in new ways.

Despite the growth seen in the co-op's 85 years of business, our core value of providing you with reliable and affordable electric service while providing excellent customer service has not changed.

After the launch of an improved online account access portal and app for members called MyClayElectric in 2021, we have continued to look for ways to serve you with current technology.

Last summer we began sending proactive outage communication messages to all members who are registered in My-ClayElectric. This means anytime there is

a system outage, registered members will receive an email or text message notifying them that we know their power is out. The notification also includes an estimated time for when power will be restored.

Another way we leveraged our online capabilities is by offering voting for the board of trustees within your MyClayElectric account. Members were able to log in to their accounts and cast their votes for the four trustees seats up for election this year. By adding this voting feature, we saw a dramatic increase in member participation in the election.

Thank you to those members who voted in this year's board of trustees election!

While voting was a new feature available just for the election from mid-January through mid-March, other features in MyClayElectric are available at all times.

These include viewing your usage; looking at your bill statements; making a payment; and keeping in communication with us. It is a great tool for managing your account.

Our commitment to excellent customer service has not changed, in both good times and bad. It's what brings us out of historical times stronger and better poised for the future.

Power cost decreases on March bills, another decrease likely for April

Members are being billed less for power in March thanks to a reduction in the Power Cost Adjustment on bills. Members using the industry household average of 1,000 kWh of power are now paying \$146. The previous cost was \$149.50. The cooperative is able to lower the cost of power due to a slight decrease in the price of natural gas, which Seminole Electric Cooperative (Clay's wholesale power provider) uses to generate a sizable portion of the wholesale electricity it provides.

If natural gas prices continue trending lower, the PCA may be lowered again in April.

The PCA is a separate line item on each Clay Electric statement, which reflects the increases/decreases in the co-op's cost of power. The cost of wholesale power is more than 70 percent of Clay's total expenses.

When the cost of power is greater than the amount included in the base rate, the PCA is a charge. When the cost is less, it's a credit.

Legislative session sees new faces, varied issues

The November 2022 elections for the Florida Senate and House saw Republicans claim supermajorities in both chambers. The makeup of the Senate is now 28 Republicans and 12 Democrats, while the House boasts 85 Republicans and 35 Democrats. There are 13 newly elected senators and 42 new house members.

Due to reapportionment, Florida's Congressional Delegation now stands at 28, with Republicans holding 20 seats and Democrats holding eight seats. There are six new members of the Congressional delegation. We are fortunate that some of these new legislators are familiar with electric cooperatives, but we have the opportunity to educate others who may be unfamiliar with the co-ops and our business model. During session, the electric cooperatives will focus on legislation that could impact our consumer-members.

The Florida Legislature met in November to hold their Organization Session, swearing in all the newly elected members. The last week in February was the sixth, and last, of the scheduled committee weeks before the start of session. This year's Legislative Session began March 7. Session lasts a total of 60 days and will conclude May 5.

There have been two special sessions since the elections. The December special session addressed: 1) property insurance; 2) disaster relief for Floridians impacted by recent hurricanes; and 3) toll relief. During the February special session, issues included: 1) creating a local government emergency bridge loan program within the Department of Economic Opportunity to provide interest-free loans to local governments affected by Hurricanes Ian and Nicole;

2) authorization for the Office of Statewide Prosecution to investigate election or voting law violations; 3) funding the transportation of unauthorized aliens; and 4) intercollegiate athlete compensation and rights. In addition, three local bills were passed relating to the Reedy Creek Improvement District, Sunshine Water Control District, and Eastpoint Water and Sewer District.

A total of 1,057 bills have been filed at this point for the 2023 regular session. The opening day of session is the last day for members to file bills. Developing a budget for the upcoming fiscal year is the primary issue for the Legislature. Currently, the Governor's recommended budget is being reviewed by the respective committees of jurisdiction. These recommendations provide a blueprint for the legislature to consider as both the House and Senate begin crafting the 2023/2024 appropriations act. The only constitutional requirement of the legislature is to pass a budget.

Some of the other issues that will be at the forefront are legislation addressing the right to carry a concealed weapon without a permit; electric vehicles; the availability of broadband internet service in rural, unserved and underserved areas; tort reform; workforce housing; and government and corporate activism. In addition, we anticipate another tax break package will be implemented.

Clay Electric is a not-for-profit electric utility and is very sensitive to government mandates that can result in increases to your electric rates or diminish the safety and reliability of the co-op's utility infrastructure. As legislation moves through the legislative process, we will continue to oppose proposals that could erode our mission to provide safe, reliable and affordable electricity.

Waste Not Want Not: Local charity diverts food to those in need in 14 counties

It's been six years since the co-op began Operation Round Up.

Since launching in October 2016, Operation Round Up has now disbursed more than \$5.65 million in funding for projects in the 14 counties served by the co-op. Funds are collected by rounding up the electric bill amounts of participating members to the nearest dollar each month.

One of the organizations that has been an annual recipient is *Waste Not Want Not*. While this charity is located in Orange Park, it provides food for food banks and other groups working to feed the hungry in 14 counties. It serves 47 charities in Clay County alone. Food is rescued from a 15-mile radius around the group's headquarters.

Many of the food banks supported by *Waste Not* are also recipients of Operation Round Up allocations, awarded through the Clay Electric Foundation.

Waste Not serves as a true middle man, collecting perishable food that would otherwise be thrown away and strategically distributing it to organizations that are in need of a particular type of food. For example, some soup kitchens are able to use large quantities of fresh food that is not packaged for distribution. Other items, like bread products, can be distributed to a variety of food pantries in the area so they can provide the items directly to those in need.

According to Sandra Staudt-Killea, executive director of *Waste Not*, for every dollar the organization receives, 15 pounds of food is provided to feed the hungry.

Last year, the group diverted 2 million pounds of food from being thrown away. Instead, it went directly to those in need.

"If there is food available and there are hungry people, we need to connect them," she said.

Food must be picked up from grocery stores like Publix and Trader Joe's. Many restaurants also provide food that would otherwise be sent to the landfill.

Waste Not is almost exclusively a volunteer organization, with 200-300 volunteers assisting in food distribution on a weekly basis. Staudt-Killea said all ages volunteer to help by picking up food, sorting and organizing items and filling orders.

On a recent Thursday, volunteers from Club Challenge (a program of Challenge Enterprises) were assisting with processing a large delivery of bread products.

Staudt-Killea also noted that they receive no government funding. The program operates exclusively through donations and grants.

"Partners like the Clay Electric Foundation allow us to continue doing what we do," she said.

Co-op members who participate in Operation Round Up donate an average of 50 cents per month, with the maximum contribution being \$11.88 per year. Operation Round Up is unique in that all funds deposited into the foundation are returned to the community. The foundation board meets each month to consider new grant requests and there are no administrative fees.

Since it began, Operation Round Up has supported domestic violence shelters, funded activities for residents with development disabilities, provided activities and critical service for seniors, provided lifesaving equipment for schools and emergency personnel, and ensured that food pantries have the necessary food to provide nourishment to the residents they serve.

"Improving the quality of life of our members and strengthening our communities was the goal of the Operation Round Up program, and we are right on target with organizations receiving checks each month," said Chief Public Relations Officer Derick Thomas.

Clay Electric is just one of many cooperatives throughout the country that has adopted Operation Round Up and fostered the mission of giving back to the community. The program was created by Palmetto Electric Cooperative in South Carolina in 1989, and has since been adopted by more than 250 other co-ops nationwide (eight in Florida). The Clay Electric Foundation Board of Directors approved

St. Catherine's Society of St. Vincent de Paul - \$15,000

(Clay County)

The Society of St. Vincent de Paul at St. Catherine's Catholic Church in Orange Park is an international organization of lay persons which allows men and women to join together in offering person-to-person service to the needy. Grant funds will be used to assist the needy with basic needs such as electric bills, water bills and rent costs.

Kiwanis Club of Starke - \$10,000 (Bradford County)

Kiwanis empowers communities to improve the world by making lasting differences in the lives of children. Funding from the grant will support math and science education programs for K-12 students.

ACORN Dental Clinic - \$15,000 (All Counties)

Founded in 1974, the ACORN Clinic uses volunteers to provide high-quality, low-cost health and dental care to low-income patients with and without insurance and with little financial resources to pay for their medical needs. The funds will support the Rural Sponsorship Program, which will provide funding for dental care to rural patients.

YMCA of Florida's First Coast Take Stock in Children - \$14,000

(Clay County)

The YMCA is the First Coast's largest service provider, touching more than 109,000 people in 2016, with programs that emphasize its core values of carling, honesty, respect and responsibility. Funds from the grant will be used to support Take Stock in Children, a mentor and scholarship program.

Clay County Habitat for Humanity - \$15,000

(Clay County)

Clay County Habitat for Humanity is a nonprofit, ecumenical Christian housing ministry dedicated to eliminating substandard housing in Clay County area. As an affiliate of Habitat for Humanity International, it works in partnership with local families and volunteers to build and rehabilitate simple, decent homes for qualified families in need. Grant funds will support the Homeownership Mortgage Assistance and Bill Relief program.

BASCA, Inc. - \$9,400 (Clay County)

BASCA, Inc. focuses on helping people with intellectual and developmental disabilities achieve a higher quality of life and sense of belonging. Funds will be used to renovate classrooms used in the Day Program.

Foundation for Florida Gateway College - \$20,000

(Columbia County)

The Foundation for Florida Gateway College exists solely to provide financial support for Florida Gateway College and the students it serves. Funds will be used to provide eight scholarships for the Commercial Vehicle Driving program.

Child Evangelism Fellowship of Florida/ Camp Good News - \$10,000

(Putnam County)

Camp Good News, located in Hawthorne, is a day camp for children and youth. Funding from the grant will be used to construct a pole barn over the basketball court.

Art League of North Florida/Gateway Art Gallery - \$5,500

(Columbia County)

The Art League of North Florida develops programs and services that serve the needs of artists through advocacy, networking, fundrais-

ing and grant development, and promotes the visual arts as an integral part of education. It offers several community art programs, such as the Girls' Summit for at-risk preteen and teenage girls (with Altrusa), the Veterans' Art Program, Art for Hospice, and the Life Style Enrichment Center. Funds from the grant will support youth programs.

Operation New Uniform - \$10,000 (All Counties)

Operation New Uniform helps veterans network and transition to fulfilling careers after their military service. Grant funds will support programming designed to help veterans transition from the military to civilian careers.

United Way of Suwannee Valley - \$10,000

(Columbia County)

The United Way of Suwannee Valley is committed to advancing the common good in its community by building strong relationships with community partner impact agencies that share the goals of improving people's lives and strengthening communities. Grant funds will support the Mission United program, which assists military veterans transition to civilian life.

ACE Mentor Program - \$12,000 (Clay County)

The ACE Mentor Program of America, Inc. helps mentor high school students and inspires them to pursue careers in design and construction. Funding from the grant will be used to fund field trips, scholarships and/or technical training for Clay County students.

Lake Area Ministries - \$20,000 (Clay, Bradford counties)

Lake Area Ministries (LAM), an all-volunteer organization, is primarily a food pantry focusing on feeding needy families. As funds allow, the organization assists with other basic needs. The funds will be used for the food assistance program.



Where to park, how to prepare for Annual Meeting March 25

Members and guests to Annual Meeting should park at the property adjacent to the Keystone Heights Junior/ Senior High School baseball/softball fields. This is the area indicated by a "P" on the map. This field is located on the corner of Orchid Avenue and Pecan Street.

The meeting will take place in front of the bleachers at the school's football stadium. There will not be a shuttle to the field; some light walking will be necessary. Those who have vehicles with a disabled person parking permit will be able to park closer to the stadium. Seating for the event will be in the bleachers. Accessible options will be available. The football field is indicated with an "M" on the map.

The meeting should last no more than 2.5 hours.



Member gathering set for Saturday, March 25

Clay Electric's 85th Annual Meeting gathering will be held Saturday, March 25 at the football stadium at Keystone Heights Junior/Senior High School. Gates will open at 8:30 a.m. and the event will last around 2.5 hours.

The gathering of members will begin with a light breakfast and all adults receiving a door prize ticket and goodie bag. The meeting will be called to order at 9:30 a.m. and will include the announcement of trustee election results and remarks from the general manager and president of the Board of Trustees. The drawing of door prizes will conclude the gathering.

Once again, the event is not taking place at the co-op's headquarters and voting for trustee elections will take place by online voting or absentee ballot only. There will be no voting in person.

Chief Public Relations Officer Derick Thomas said several factors, including meeting facilities, cost, safety and parking prompted the changes to the Annual Meeting gathering and how voting takes place. To accommodate the change in the day of the gathering and the co-op's growing membership, it

was decided to move the event to another venue in Clay Electric's hometown of Keystone Heights. The high school football stadium was determined to be the best location to provide the parking, seating and other options needed.

Voters entered into a drawing for bill credit prizes

Voting for the Board of Trustees seats up for election is online or by absentee ballot only. Members who requested a ballot should fill it out and mail it back as soon as possible. Ballots must be received by 4 p.m. March 13 via U.S. mail in the return envelope provided to the designated address for the ballots to count.

All members who vote online or by mail-in absentee ballot will be placed in a prize drawing contest to win one of 43 bill credits.
