## What you tell us helps us grow

Throughout the year, we check in with our members through the American Customer Satisfaction Index (ACSI) survey. The latest results are in, and I want to share some of what you told us — because it matters.

Our most recent survey shows your cooperative earned an ACSI score of 86 out of 100, above the national benchmark for electric cooperatives. Your overall satisfaction came in at 8.9 out of 10. Those aren't just numbers; they're a reflection of the trust and connection you have with your co-op.

One thing that stood out to us is how much identity plays a role in your satisfaction. Those who truly take note of the fact that they are indeed “member-owners” of Clay Electric rated us at 9.4 compared to 8.5 for those who said “customer.” That's proof that the co-op difference is real, and I want to remind you — our members — that you're not just paying a bill each month.

You're part of something that you own.

A couple more things to point out:

**You said:** Long relationships build trust, but new members value us, too.

**We heard:** Keep earning it. Members of more than 20 years rated us highest (9.04), and those under two years in rated us almost as high (8.89). The mid-tenure group (2–20 years) dipped slightly (8.63), but we'll keep looking for ways to improve.

**You said:** You appreciate our personal interactions and communication.

**We heard:** That's a strength worth protecting. We'll continue to keep you informed and make sure that every conversation, behind a screen or in the field, reminds you that we're part of your community, too.

Your feedback isn't just filed away — it shapes how we serve you. Thank you for taking the time to tell us how we're doing. We're listening.

## Upgrade means faster response times

We've rolled out an upgrade to your home's Advanced Metering Infrastructure (AMI) — part of our continued commitment to faster response times and more reliable service.

### What's Changed?

Until now, AMI helped confirm the location of outages. With this upgrade, it now alerts us when an outage happens — sometimes before you even know there's a problem. That means we can act faster, get

crews moving sooner, and restore power more efficiently

Of course, your reports via the **MyClayElectric** app or a phone call are still key. But now, we've got another set of eyes on the system — and they're working 24/7.

### Why it matters

- We can now detect and fix problems like failing transformers before they cause major issues.
- Engineers get real-time voltage data — not estimates — helping us pinpoint and fix power quality problems like low or high voltage.
- Outage notifications, restoration updates, and real-time data are pushed right to you through our app, text or email.

### Bottom line:

This AMI upgrade gives us the tools to keep your service smarter, stronger, and more reliable.

## New transmission line will strengthen the system

In your cooperative's Salt Springs District, crews spent several weeks clearing a path for a new transmission line — and now the real building is set to begin. When the project is finished, members living in the region will have more reliable service and faster restoration times, especially during major storms.

Right now, the Fort McCoy and Salt Springs substations are each powered by a single “radial” transmission line running through wooded areas. If a tree falls or a pole breaks, we must send a crew to repair it before your power can come back on. This new transmission line will connect the two substations in a loop. If there's damage in one direction, we'll simply feed electricity from the other side, getting your lights back on quickly while repairs are made.

The new line will run from Fort McCoy to Salt Springs along a route chosen after careful study. We looked at three possible options and selected the one that follows our existing distribution path. This helps reduce construction costs, minimize

environmental impact and avoid disruptions to nearby homes.

Before any work began, we completed a full environmental survey. Our crews marked wetlands, flagged gopher tortoise burrows, identified red-cockaded woodpecker habitats and posted notices for other protected species. We also went through a thorough permitting process with the Florida Department of Environmental Protection, the U.S. Army Corps of Engineers, the U.S. Forest Service and other agencies to ensure we meet environmental standards.

We don't expect members to experience outages because of this work. The project will take several months to more than a year to complete, but when it's done, the Salt Springs area will have a stronger, more resilient electric system.

## Powered up ⚡

Many homes and businesses in the co-op's Palatka District recently got an upgrade.

Our crews boosted reliability by doubling voltage along Georgetown Feeder 2, upgrading 900+ transformers in two days. The upgrade means steadier power, fewer outages and less strain on equipment — keeping homes and businesses running smoothly.

It's all part of a voltage conversion, something we're doing quite frequently in our districts. During a conversion, also known as a cutover, lines are de-energized, grounded for safety and transformers are switched from 7.2kV to 14.4kV, effectively doubling the voltage.

## You stopped a tax hike 💰

Clay Electric members and Clay County residents spoke up — and county commissioners listened.

Recently, they voted 4-1 to reject a proposed hike that would have raised the utility tax from 4% to 10% for customers in unincorporated areas, including many Clay Electric members. Thanks to commissioners John Sgromolo, Alexandra Compere, Betsy Condon and Kristen Burke for standing with residents and pushing for smarter budget solutions.

## Terri Kane brings community roots, financial insight to Board

As a child, Terri Kane's earliest memories of being part of a cooperative were under a tent at the Clay Electric Annual Meeting. The decision to run for a position on Clay's Board of Trustees wasn't driven by ambition, but a motivation to serve the community where she grew up.

Wacahoota, a small unincorporated town in Florida just outside Micanopy, is where she started, and it's where she chose to return. Years later, she represents her rural community within Clay Electric's eighth district.

Kane brings with her over four decades of accounting experience. A sixth-generation Floridian, she left the state in 1979 to attend Auburn University and later moved to Nashville, where she became a partner in a certified public accounting firm. But in 1996, she decided Florida was where she belonged.

"I walked into my partner's office in Nashville and said, 'I'm going

home," she recalled. "Moved back home with a husband, two kids, and a dog."

Kane settled in, built a home, restarted her accounting career and became deeply involved in the area — not just as a resident, but as someone who gave back through board service and volunteer work. As a trustee, she hopes to bring institutional knowledge and practical skills to the table.

When it comes to financial oversight and other strategic questions, she's confident she brings skills to the table. She knows her limits, too.

"I can't go climb a pole. I guarantee that isn't going to happen," she chuckled. "But I know I can do a good job."

What matters most to her is that the Board stays engaged and active. She wants to be part of a group that asks hard questions, solves problems and isn't afraid to move forward.

In her free time — what little there is between work and caring for her mother — she tries to see her four grandchildren, split between Indiana and South Florida.

Kane didn't name any personal heroes, but she values an open mind and conversation.

"A lot of people inspire me, and I like talking to people, I like listening," Kane said. "You don't have to agree with everybody, but you can be professionally polite, and we can all gain something from anybody."



## FEMA Act promises faster disaster relief for co-ops

Did you know that your cooperative is still waiting to receive millions of dollars in federal reimbursement funds from FEMA for damage due to storms dating from last summer back to Hurricane Ian in 2022?

We'll be frank. As of June 30, of a total \$26.3 million in eligible reimbursement funds, we'd only received about \$2.9 million — meaning we were still waiting for more than \$23 million. Of hurricanes Debby, Helene and Milton, which hit last year, we'd received a grand total of \$0 in FEMA reimbursement.

Imagine waiting **months** instead of **years** to receive disaster aid. That's part of a bill your cooperative supports, and we're working with the National Rural Electric Cooperative Association (NRECA), Florida's Electric Cooperatives (FECA) and our local representatives Kat Cammack (R, Fla.

District 3), Aaron Bean (R, Fla. District 4) and Randy Fine (R, Fla. District 6) in hopes of it receiving Congressional approval.

It's called the Fixing Emergency Management for Americans (FEMA) Act of 2025, and it has backing across party lines. It aims to do three key things:

- Slash bureaucratic delays.
- Allow co-ops (like Clay Electric) to rebuild with stronger systems.
- Restore FEMA's status as a stand-alone agency.

"We sincerely thank our local representatives for supporting the FEMA Act of 2025. This legislation ensures Clay Electric can respond quickly after storms and disasters," said Chief Public Relations Officer Derick Thomas. "By streamlining disaster aid and allowing us to build stronger, more resilient systems, it helps protect our members, future-proofs our infrastructure and ensures the communities we serve will receive reliable and affordable electricity."

The FEMA Act would impose strict deadlines, including 120 days for emergency work reimbursements, 90 days for reviewing long-term project estimates and 30 more days to

disburse those funds. Co-ops impacted by disasters could build back with improvements (think an upgraded ductile iron pole vs. a wooden pole) and a more resilient system opposed to being forced to rebuild exactly how things were before.

There would also be a structural shift with FEMA, which would move out from under the Department of Homeland Security and become an independent agency reporting directly to the president, something it used to do pre-2003.

Here's the bottom line: When the co-op faces economic hardships, such as those caused by a natural disaster, that impacts you, our members, who also reap the benefits when the cost to produce electricity takes a dive. So for the 900+ co-ops serving rural America, FEMA's Public Assistance program isn't an option. Advocates say the FEMA Act of 2025 would reduce red tape, strengthen resilience and prevent already vulnerable communities from bearing the cost of delayed aid.

The bill faces a full House vote, Senate approval and a signature from President Donald Trump before becoming law. Hearings are slated for this month when Congress reconvenes.

Nonprofit that provides healthcare to uninsured adults and children in underserved areas. Funds help provide school-readiness vaccinations, vision screenings and heart testing for cardiac defects.

**Goodwill Industries of North Florida (Putnam County) \$10,000**

Not-for-profit that removes barriers to employment through training, education and career opportunities. Funding helps the Take Stock in Children program provide college scholarships.

**Dignity Impact Outreach \$10,000 (Clay County)**

Nonprofit dedicated to restoring dignity and hope to those facing hygiene insecurity by providing essential supplies. Funds support the distribution of hygiene products to students.

**Feed the Need \$10,000 (Putnam County)**

Exists to end childhood hunger over the week-ends in Putnam County by providing meals to 850+ children. Funds will be applied to the installation of perimeter fencing and security cameras for the warehouse.

**Catholic Charities Bureau Lake City (Columbia County) \$10,000**

Nonprofit that provides services to the most vulnerable people in the community. Funds support the Emergency Assistance Program, which provides financial assistance for essential utilities and housing costs.

Operation Round Up is made possible entirely by the generosity of Clay Electric members, who voluntarily elect to round up their monthly bill to the nearest dollar. The tax-deductible amount is then donated to the Clay Electric Foundation to support local charities and nonprofits.
